NOTICE TO SHAREHOLDERS of the sub-funds listed in the below appendix (the “Sub-Funds”)

Dear Shareholders,

The board of directors of the Company (the “**Board**”) hereby informs the Shareholders that the index administrator MSCI Limited (the “**Index Administrator**”) has decided to modify the methodology of certain of its indexes, being the “MSCI ESG Broad CTB Select Indexes” (the “**Indexes**”) and that consequently, the Prospectus and the SFDR annexes of the Sub-Funds have been amended (the “**Modifications**”) in order to reflect the latest evolution of the Indexes methodology (the “**Update**”), that is effective since the February 2026 Index review.

The Index methodology is being amended to seek to minimise the tracking error of the Index against the “Parent Index” while continuing to meet the minimum standards for an EU Climate Transition Benchmark under the EU Benchmarks Regulation.

The Index Administrator has decided to update the optimization process applied in the construction of the Indexes; the Index’s existing target to maximise the Index’s exposure to ESG scores compared with the Parent Index is being amended so that the Index will now seek to achieve an ESG score at least equal to or greater than the ESG score of the Parent Index.

Importantly, the Modifications do not represent a change to the investment objective, nor a material change to the investment policy of the Sub-Funds. There is no change to the minimum proportion of sustainable investments of the Sub-Funds. The other characteristics of the Sub-Funds remain unchanged.

As a consequence of this Update, the Prospectus (including the SFDR Annexes) will be amended accordingly.
